These children receive an age appropriate book through the mail each month. The program is designed to help children build vocabularies and discover reading. It also builds bonds between parents and adult relatives and the children as they help foster the love of reading. There is no cost to families to enroll their child and the child receives 12 books a year until their 5th birthday. This is one way United Way's education initiative helps prepare children for kindergarten.**

The Kandiyohi County Empower group utilizes the dollars they raise in four different ways: 5% to support Imagination Library; 15% for getting educational materials into the hands of parents and funding preschool backpacks that have tools to help prepare preschoolers for kindergarten; 30% of the funds are used to provide early childhood grants addressing school readiness. The remaining 50% goes toward the

"Growmobile," which is a mobile program that provides onsite preschool in targeted regions in our communities year round. The Litchfield Empower group hosts events to raise money and awareness in Litchfield and the surrounding communities. This group uses the funds raised to pay for transportation costs for area children whose families are unable to provide safe and reliable transportation to and from preschool.
