Education: making sure our children come to school prepared to succeed, supporting them throughout their school career, and helping people of all ages gain job skills, creating a ripple effect of success throughout our United Way communities. Health: promoting access to affordable quality physical, mental, and dental health care; promoting independent living and quality of life programs and promoting access to programs that teach healthy behaviors and promote wellness to prevent future problems. Basic Needs: supporting programs and agencies that provide building blocks for a good life for individuals and families in West Central Minnesota.

United Way coordinates and funds the Dolly Parton Imagination Library program. United Way has over 2,700 preschool children enrolled (from birth to age 5). These children receive an age-appropriate book through the mail each month. The program is designed to help children build vocabularies and discover reading. It also builds bonds between parents and adult relatives and the children as they help foster the love of reading. There is no cost to families to enroll their child and the child receives 12 books a year until their 5th birthday. This is one-way United Way's education initiative helps prepare children for kindergarten.
